

WHEAT (STOCK DECLARATION BY COMPANIES OR FIRMS OR INDIVIDUALS) ORDER, 2007

ORDER

New Delhi, the 1st March, 2007

S.O. 305(E):— In exercise of the powers conferred by Section 3 of the Essential Commodities Act, 1955 (10 of 1955), the Central Government hereby makes the following Order, namely:-

1. Short title, extent, commencement and application: —

- (1) This Order may be called the Wheat (Stock Declaration by Companies or Firms or Individuals) Order, 2007.
- (2) It extends to the whole of India.
- (3) It shall come into force on the date of its publication in the Official Gazette.
- (4) It shall not apply to any wheat purchased by or on behalf of the Food Corporation of India.

2. Definitions:- In this Order, unless the context otherwise requires:-

- (a) "Food Corporation of India" means the Food Corporation of India established under Section 3 of the Food Corporation of India Act, 1964 (37 of 1964);
- (b) "Form" means a form annexed to this Order;
- (c) "Wheat" means dried mature grains of *Triticum vulgare*, *T compactum*, *T sphaerococcum*, *T durum*, *T aestivum* and *T dicoccum*.
- (d) "Company" means a Company notified under the Companies Act, 1956 (10 of 1956).

3. Return relating to purchase of wheat by a Company or Firm or Individual:- Any Company or Firm or Individual who purchases wheat beyond 50,000 tonnes (total purchases made throughout the country) during the Rabi Marketing season 2007-08 (April-March), shall furnish to the Under Secretary (Policy III), Department of Food and Public Distribution, Krishi Bhavan, New Delhi-110001 (FAX No. 011-23782213) a return in the Form and at such intervals specified by the Central Government.
