

Privacy Policy for “Mera Ration Meri Dukan” (MRMD) Mobile App

This privacy policy governs your use of the software applications (“Applications”) for mobile devices that was hosted at NIC e-Gov Mobile App Store in Google Play. The Applications mainly provide eGovernance Services delivery and intends to provide better citizen services by the government. The contents published on these Applications were provided by the concerned “Food and Civil Supplies Department of Government of Rajasthan” or the allied government establishment. This information provided through these applications may not have any legal sanctity and are for general reference only, unless otherwise specified. However, every effort has been made to provide accurate and reliable information through these applications. Users are advised to verify the correctness of the facts published here from the concerned authorities. User Provided Information:

The Applications may obtain the information you provide when you download and register the Application. The very first time Registration is mandatory but after that user can directly login to the app. However, please keep in mind that you will not be able to use any feature offered by this Application unless you register.

There are two logins in this application. One for citizens and other for fps dealers However a user can choose its type and further communicate with this application. This app provides all required data for FPS & Ration card holder.

The information you provided may be used to contact you from time to time to provide you with important information and required notices.

Automatically Collected Information:

In addition, the Application may collect certain information automatically, including, but not limited to, the type of mobile device you use, your mobile devices unique device ID, the IP address of your mobile device, your mobile operating system, the type of mobile Internet browsers you use, and information about the way you use the Application.

When you visit the mobile application, it may use GPS technology (or other similar technology) to determine your current location in order to determine the city you are located within and display a location map. The location information may be sent to authorities for taking necessary actions and making policy decisions.

If you do not want the app to use your location for the purposes set forth above, you should turn off the location services for the mobile application located in your

account settings or in your mobile phone settings and/or within the mobile application. However, if the service provided by the Application requires the location services using GPS technology, such services offered by the application will not be available for you.

We may disclose User provided and Automatically Collected Information:

You can stop all collection of information by the Application easily by uninstalling the Application. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network.

Data Retention Policy, Managing Your Information

We will retain User provided data for as long as you use the Application and for a reasonable time thereafter. We will retain Automatically Collected information also for a reasonable period of time depending on the nature of application and thereafter may store it in aggregate. Please note that some or all of the User Provided Data may be required in order for the Application to function properly.

Misuse by Non Targeted Users

All mobile apps are meant for use by the targeted audience only. Misuse by non-targeted users should be prevented by owner of the mobile.
